- 5 It is difficult to estimate taxable profit/income for the year end as on 31st March, 2017 in view of the seasonal nature of tea business and hence Current and Deferred tax shall be provided at the end of the year.
- 6 As per paragraph 32 of Revised Accounting Standard(AS 10) Property Plant & Equipment, the Company has opted to adopt the Revaluation Model as prescribed therein for Bearer Plants and the cost model for other class of Assets.
- As per the requirement of Revised Accounting Standard(AS 10) Property Plant & Equipment effective from 1st April 2016, depreciation amounting to Rs. 24.21 Lacs on bearer plant has been provided during the nine months ended 31st December 2016. Further, Replantation Expenditure amounting to Rs. 42.45 Lacs incurred during. Nine months ended 31st December 2016, has been capitalised, which was hithereto charged to Profit and Loss Account. As a result, Profit for the Quater and Nine moths ended 31st December 2016, is higher by Rs.18.24 Lacs respectively.
