The amount utilized in the Buyback was ₹ 59,40,00,000/- (Rupees Fifty Nine Crores Forty Lakhs Only) excluding transaction costs viz. brokerage, applicable taxes such as stamp duty, GST, stamp duty, filing fees, advisors fees, public announcement expenses, printing and dispatch expenses and other incidental and related expenses.  
In addition to the Buyback i.e. Link Intime India Private Limited ("Registrar"), considered 8,033 applications for 3,42,09,195 Equity Shares in response to the Buyback.
